\_\_\_\_\_ In the event that I resign or am dismissed as a volunteer, I agree to fully cooperate and promptly make arrangements to return any and all parrots, cages, equipment, etc., that are property of C.A.A.R.E. I understand that failure to do so will result in my being charged for the property's replacement cost.

\_\_\_\_\_ If I will be sheltering or providing foster care or boarding any of C.A.A.R.E.'s parrots in my home or business, I consent to C.A.A.R.E. visiting my home or business from time to time to observe parrots and their living quarters.
